January

Friday 1 Ft. Macleod

Weather fine. The day kept quietly. Service in C of S. Dined at home

Saturday 2 Ft Macleod

Weather fine. Received a telegram from the Commissioner to the effect that Col. Herchmer had died at Calgary (suddenly) last night. It was a great shock and surprise to us for although an extremely suspicious man and apt to lend himself to the schemes of his brother and aid him in his attempts to ill treat his officers, yet he, if let alone, would have been as much better man.

I gave Aylen and Baker leave to go to Calgary to the funeral but the latter could not get away. Gave orders for the flag to fly at half mast until further orders.

Sunday 3 Ft. Macleod

Weather fine. did not go to church had too much for the mail. Sanders took charge of the C of E detachment.

Wrote a good deal in the afternoon. Most people thought that Colonel Herchmers sudden death could not attributed to suicide, but a telegram from Insp Allan(?) to Col Macleod settled that matter as it proved to be fatty degeneration of the heart. He took ill at 10 and died at 11.00.

Monday 4 Ft. Macleod

Recd. telegram from Denny and Sergt Cotter saying that Forde who is charged with killing one May-hew near Saint Marys, had been captured and could be tried before J.P. Wired to Denny not to let the fellow escape at any hazard

Busy all day in court etc The quarterly Bd on stock culling is on hand and has orders to be very strict

Wired Crown Prosceutor about Fordes case

Tuesday 5 Macleod N. W.Ty.

Weather fine. This is my birthday and Bakers. We did \_\_\_\_ any. Times have changed since we had a little pleasure on such occasions.

Busy in orderly room, visited Gd cells and stables saddle rooms etc.

Telegram from Denny saying that Forde was committed to stand his trial on the fifteenth and asking for \_\_\_\_ and Crown Prosecutor

Wired Messrs Conybeare & Galliher on the subject and repeated Dennys telegram Have not had a reply on this subject.

Wednesday 6 Macleod

Weather fine but a little windy. Lots of work going on, the quarterly board and other things (word x'ed out) Johnson & Johnson sent up word asking for half the fine in Reg.vs \_\_\_\_ ( if paid) Something fishy in this Sent for the interpreter to see to it

Reported the case in writing to Judge Macleod

Johnson& Johnson re Reg. vs \_\_\_\_ for selling \_\_\_\_ to Indians

Took desposition of Whitford in this case.

Thursday 7 Macleod

Weather fine. Telegram from Denny saying that he had got Fords case put off until the 20<sup>th</sup> instance Wired copy to Conybeare and Galliher at once and also wired them saying that I would be ready with the witnessess for extraditions as soon as they were ready for them. Visited sick stables, Hospital and looked around the barracks at 1200 Did \_\_\_\_ work in orderly room. Clarkson(?) then \_\_\_\_ a/c

Ordered new stable brooms for sick stable

Asst Surgeon Aylen returned from Calgary today.

Friday 8 Macleod

Weather fine. Visited Gd. cells, stables, \_\_\_\_ room stables. Issued poison (wolf) license to John Daniels a half breed. It is to be set out in the porcupines. Conybeare writes saying that the crown pros. will be ready to go at any time to the States to extradite Ford. And suggested that witnesses go this way. Mailed letter to Mr C. Clarke, \_\_ Steele, Mr Mann(?), Mr. R Harwood, Supt Deane, Corporal Brown per \_\_ Humfrey \_\_\_\_\_ last with \$25.00 in it for Morrison at Fish Creek on a/c of butter received from him (the Mormon )

Saturday 9 Ft. Macleod.

Weather fine. Nothing of importance going on attended to work as usual.

Sunday 10 Macleod NWTy.

Weather fine. (x'ed out \_\_\_\_ laid an information against one Donneley for having liquor intoxicants illegally in his possession. I sent for him by \_\_\_\_ and \_\_\_\_\_ to appear tomorrow)

Weather very cold & stormy. 10 °below zero. No church parade today. Wrote lots of letter to different parties on business.

Monday 11 Macleod N.W.Ty.

Weather fine but a little sharp, zero at 10.00 but later it cleared up finely. Busy at various cases. Col. Macleod came up re. Johnson & Johnson for black mailing the Mormon who charged some Indians with stealing and killing cattle. \_\_\_\_ well filled up again. Ford searched and said that he was satisfied at the affair being concluded and that the police had done their duty as well as possible and that nothing was found.

Paid I.G. Baker a cheque for one hundred dols from Dr. Allen to me on Cowdry Bros Macpherson in.

Tuesday 12 Macleod

Weather fine. busy all morning at correspondence and various cases arranged for witnesses in extradition cases to be ready at St. Marys on the night of the 15<sup>th</sup> Wired Galliher to that effect. Case against one Donnelly for having liquor illegally in his possession.

### Wednesday 13 Macleod

Howard went out to the Southern detachments today, gave him orders to send in a reply to my letter to the Mormon Storekeeper by special messenger. Explained that I had written about it some days previous and deserved a prompt reply

Informed Howard that he would be relieved by Inspector Davidson

### Thursday 14 Macleod. N.W.Ty

(xed out Ft. Macleod) Busy all day. Galliher arrd from Lethbridge. Made arrangements for Matthews Galliher and Dr Aylen to go south to extradite Frank Ford Ordered that they be made as comfortable as possible. Gave \_\_\_ & \_\_\_ orders to the effect. Gave Insp Mattheus fifty dollars (\$50.00) for expenses and warned him to keep them within bounds.

### Friday 15 Macleod

Inspected Stables, Hospital, Saddle rooms. Found D Saddle room not clean, and the saddles in it dusty. Matthews, Aylen & Galliher Crown Prosecutor started at 10 AM to extradite Frank Ford, two four horse teams were with them. All are comfortable. Chinook blowing quite mild. Forty two degrees difference between the temperatures last night and was 32° above zero now Eleven (11) below last night at 7.30

Sergt Cotter(?) will go with the party to the S. Peigan agency as guide.

Saturday 16 Ft. Macleod

Weather fine. Nothing of importance. Sentenced Const McDowell to 3 mos Hard Labor for "carrying a letter from a vagrant in the Guardroom to a woman of low character in town" Sent one hundred dollars to Matthews he asked for a great deal more but I would not allow it

Busy at correspondence etc from (*xed out* noon) 9.30 until 12.30

Sunday Ft. Macleod

Weather fine. No parade for C of S – all others held. Did some work in the orderly room. Looked over the quarterly board on the whole it is more like it should be than the last. Baker has done well.

Monday 18 Ft. Macleod

Weather fine. Nothing of importance. Tried several breaches of discipline in the orderly room, visited \_\_\_\_ stables hospital, Recreation room, Gd room, cells sentries and attended to correspondence in the morning.

Tuesday 19

The mail today. Busy working in the office. Cmr sits at Regina today, mail did not bring much in except reports from Denny all \_\_\_\_ as usual. Visited \_\_\_\_.

Wednesday 20 Macleod

Weather fine 33° Busy all morning. The extradition trial of Frank Ford for killing Matthews sits today at the Agency

Very windy indeed. Clerks busy checking the issues of \_\_\_ by the parade states.

Inspr Davidson arrd at 5 P.M. but was ordered to Regina with Sanders by the Comr I suppose as witnesses in the case.

Gave orders for team to take them in time for first train tomorrow morning

Did some work in the evening

Mrs Zack Wood arrived last night from Maple Creek.

Thursday 21 Ft. Macleod

Weather fine. Busy all morning at returns etc went to \_\_\_ stables found some faults and corrected them. Put in orders instructions about some stable duties. Insp Davidson & Sanders started for Regina at 10.30 to catch evening train at Lethbridge.

Mail in early. The Macdonnells had a five o'clock tea, a great many there. Got several letters and wrote A.R. Dickey J.B. Clarke, James Ross. Mac wrote McLennan he says.

Friday 22 Macleod

Weather mild, 45°

Busy at routine did a lot, visited and attended noon stables which did no harm.

Wrote Macpherson re the report against Edwards supposed to have sold ammunition at Cut Banks Montana

S Const Denny arrived at about 7.00 P.M. reports all right at The Agency, but the Ford Case put off until the 25<sup>th</sup>.

Reports Agent \_\_\_ still annoyed at the report that one Edwards sold ammunition on the S. Peigan Res. to Canadian Indians and \_\_\_ had written to Washington denying flatly what \_\_\_ said

### Saturday 23 Macleod

Weather fine. Thermometer 55° strong Chinook blowing. Received Macphersons report explaining the thing re Indians getting ammunition from American trader at Cu banks. The story was untrue probably unintentional on account of wrong interpreting by Wagner(?).

White-Fraser here

### Sunday 24 Macleod

Weather very fine drove out in the afternoon with Mays and the youngster. Very pleasant and did us good

Prairie fire started by the burning of Rothwells(?) hay stacks by an incendiary. Sent Sgt Spicer out to save what could be and stop prairie fire, did the latter \_\_\_ got further east \_\_\_ the Stand Off trail. A very good days work by the men.

### Monday 25 Macleod

Constable Johnsons box searched for having stolen pipes and cigars of Bleasdells. Some were found and Johnson taken into custody. Wrote to Macpherson about the sale of ammunition to our Indians by Amer traders and told him that \_\_\_ the trader did not live at B\_\_\_ Creek nor at Cut Banks where the am. \_\_\_ sold. Issued a

summons for Kid Moyles for refusing to go out to a prairie fire under the Ordinance  
Const Johnson arrested for theft of goods from Bleasdells store, goods found on him.

Usual routine

Thursday 28 Macleod

Weather fine Nothing of importance Usual routine

Friday 29

Col Irvine arrived from Calgary

Morris picked him up at Pincher Creek. Col. Looks well.

Saturday 30 Macleod

Weather fine usual routine. Macdonnell went up to Pincher Creek to attend a meeting

Sunday 31 Macleod

Weather fine. Did not go to church today. Another prairie fire at Rothwells, all his harness oats etc were burnt. One Sutton arrested on suspicion of having done this.

Col. Irvine on hand (*xed out* that night) at my house stayed until about ten o'clock. Macdonnell back from Pincher Creek.

## February

Monday 1 Macleod

Fine. No snow. Sutton charged with arson remanded until tomorrow. Wagner brought up as a thief dismissed with not a stain on his character. Busy at other matters. Dismissed the charge against Constable Ryan who was told off to watch the man Ford supposed to have murdered one Mayhew.

Dismissed (with Sanders) charge against one Wagner a lad who had been employed as an interpreter by the Force. Charged with having J.W. \_\_\_'s watch unlawfully in possession.

Tuesday 2 Macleod

Weather fine. No Snow Strong S.Wind by noon

30° at 10.00 and 45° above at 12.00

Dismissed the charge against one "Dutch Frank" for taking a pig unlawfully. It appears that \_\_\_ bought it and did not pay for it and it was returned taken back by Frank Fontaine (Dutch Frank)

Visited stables , Vety and others, Gd room, cells, all in good shape stables improved a good deal. Dismissed charge of burning stable and barn of Rothwell by one Sutton Attended to other work

Wednesday 3 Ft Macleod

Rothwell came to me and got permission to have Humfrey work up the burning of the barn and stables. I was busy at routine (x'ed out sent) went around the barracks, and visited the sick in hospital etc etc

Dance in the mens qrs. given by their quadrille club.

Plots by that very nice fellow at Regina are being exposed daily. The son of a gun wi have a nice time of it

Thursday 4 Macleod

Routine work. Two drunks and some minor offences \_\_\_\_ tried at orderly Room Weather fine 45° above 0. \_\_\_\_ and officers up to see me on official business.

Friday 5 Macleod

Weather fine. 45°-50°in the shade

Tried Constable Jarvis of D. Division for associating with bad characters and sentenced him to one month inpt with H. L. He gave me a lot of trouble by denying (x'ed out this) the chg and causing large number of witnesses to appear to prove it

Morris & Wroughton, the latter on duty, to Lethbridge.

Saturday 6 Macleod

Nothing of any importance on hand, busy at ordinary routine. G De Beary(?) in Left for the East on leave. Drayner and Sergt Martin from Regina the latter ostensibly to measure the men for uniforms in reality on some dirty job of the Commissioners I firmly believe

Sgt Barker to the Porcupines to take chg Sergt Roby to the Boundary creek to do likewise. Gave them instruction before starting for the destination.

#### Sunday 7 Macleod

Did not go to church. cannot do so as long as I am in the frame of mind caused by the Force. Busy at my mail

#### Monday 8 Macleod

Weather fine. Busy at routine work in the orderly room. Fined two men for drunkenness. Sent a reply to Comr (McIllree) about a charge against one Const Somerville of the Force.

#### Tuesday 9 Macleod

Weather fine. Nothing going on of importance G Rothwell arrested and admitted to bail for "shooting with intent"

Ball by single officers tonight proved a great success. Corporal Rickman remanded for neglect today \_\_ and absent from his detachment

Mail in. The Police Commission adjourned until the return of Judge Wetmore whose son is dying necessitating the Judges return home to the lad. Chinook blowing all day.

#### Wednesday 10 Macleod

Weather fine (x'ed out all day) D.J. Campbell explained when prisoners are to be tried (x'ed outand) when and who. Reduced Corporal Rickman to the ranks today for several offences. Absences being among them and neglect of duty.

Sgt Martin and Sgt. Morrison to south to measure the men for their uniforms. Const Johnson arraigned before Judge Macleod for larceny of pipes etc and sentenced to 12 mos. impt with H.L. Lone Man arrested for assault upon his wife. Dance at Sergt Mess.

(x'ed out Thursday Friday 11 12 13) Macleod

Weather fine. West and Sanders and I fined one McGillis drunk and causing a disturbance. I fined Lone Man for assault upon his wife \_\_\_\_ fine paid. One Stephenson brought in from St Marys and confined in the Gd room for an attempt to commit rape on his daughter. She is expected here. Steals fire in here today from Lethbridge with Sgt Hilliard. Chinook \_\_\_\_ all day. Nothing doing after dinner. S Sergt. Hilliard brought in Steals fire from Lethbridge . Nigger Minstrel show in the Recreation room, very good. Stormy

Friday (x'ed out Thursday 12) Macleod

Court sitting today Nothing of importance. Sent witnesses down to see about it. Committed Stephenson for indecent assault on daughter. Released Nolle Prosequi being \_\_\_\_ Fine in the morning, but a heavy blizzard preceeded by a regular hurricane. came on at 1200 hay stacks supposed \_\_\_\_ as it \_\_\_\_ those on the bound(?) side.

Men had a minstrel show in the town hall

Saturday 13 Macleod

Signed monthly returns and mail for this Monday. Sanders and I sentenced Lone Mans wife to \$1.00 and costs for assaulting Angelique S\_\_. Murray came to see me and asked me to push his application for pension through the officers in Washington which I arranged to do as he can get no one else.

Very wintry indeed but not cold. Snow is on the ground about an inch deep.

Sunday 14 Macleod

Stormy and cold. No church parade. Busy part of the time in the office.

Monday 15 Macleod

Weather fine. Thermometer at zero (0) until 12.30 when Chinook raised the temperature and drove the \_\_\_\_\_. Dealt with a few matters of discipline and

commenced the preliminary on \_\_\_\_ for shooting with intent. I do not believe the woman Laura Clifton who makes the statement Several cases on hand

Sent a note of \_\_\_\_ to Colonel Irvine \_\_\_\_ a man looking for horses for several men at High River etc

Retired at midnight as usual.

Tuesday 16 Macleod

The prisoner T Johnson(?) up and sentenced to twelve mos. to run concurrent with Judge Macleods sentence for Larceny etc. Sentenced same man to two mos additiona for disob of orders in prison and bad language while at work. Busy at returns and many other \_\_\_\_.

Wednesday 17 Macleod

Weather cold. I am confined to the house with sore throat . I ordered that \_\_\_\_ one (1) room "D" Divn to be vacated for the Commission and the men placed in the vacant hospital ward or elsewhere if necessary

They have been put in the hospital and in the other room of their Division.

Thursday 18 Macleod

Weather improved 15° above zero. Throat better. Men of D. \_\_\_\_ moved into vacant ward are quite comfortable . Signed and attended to all my correspondence to-day. No breaches of discipline to be tried.

Remanded one Smyth(?) again as Laura Clifton is still too unwell to appear against him.

Mays drove out with the Girl(?) and the youngster. Comr wired that teams would be required on Monday at the \_\_\_\_ to bring party from Lethbridge to this place. Deane replied to and asked to wire exact date when he knows of it

Friday 19 Macleod

Weather fine. Mercury 15° inspected the barracks, recreation room, stables etc all correct. \_\_\_\_ up other routine matters. Men cleaning houses(?) etc. etc.

Saturday 20 Macleod

Weather fine, but cold

Usual routine

Sunday 21 Macleod

Weather fine Nothing of consequence. Mercury 15 above zero. Church parade as usual. I attended as did all those not on duty or sick.

Inspected the divisions messes, barrack rooms, ablutions rooms, Kitchens Hospital, Recreation room, stables, saddle room and canteen. Everything in \_\_\_\_ order and no complaints. Guard room and cells in particularly good order.

Monday 22 Macleod

Weather fine. Soft gentle Chinook blowing mercury 45°. Inspected stables, hospital, Saddle room etc. Attended to routine \_\_\_\_ prisoner Murray(?) on account \_\_\_\_ to \_\_\_\_ by Neale and me. It is to be handed in to Dr. Allen

Sent Humfrey(?) on special duty to Boundary Creek & to report to Dr. Allen Coll of Customs and at B. Creek to get Denny and Const Percival to work with him. Wrote out instructions for all and to Sergt Roby.

Saturday 5 Macleod

Weather fine. Wroughton Haultain and Morris to Lethbridge in a K. Division wagon.

Sent telegram to Haultain to get evidence in rebuttal put in re the Comrs statements.

Macdonell ditto to Judge(?) for same.

Mess meeting today D.J. Campbell was asked with unanimous consent not to appear in the mess again. Copy to be sent to all messes of the Police.

Sunday 6 Macleod

Weather windy, no parade. Z.T. Wood and wife with team to Lethbridge en route to Pincher Creek

Monday 7 Macleod

Weather fine. Busy all day. Sent orders to have team for Judge Macleod to go to P. Creek. He countermanded the order at once as he was unwell. Decided to start at 3 P.M. but could not. Got no reply from Haultain re the Judge

Tuesday 8 Macleod

Weather fine. Cold in the morning and some snow. Afternoon clear. Sgt Wright(?) handed in his books etc to Corpl Provost (*xed out* on the) Orders to go to Lees Creek for himself and take charge via Big Bend detachment.

Signed all my a/c etc etc. Wrote many letters (official and private)

Wednesday 9 Macleod

Weather fine. Routine

Thursday 10 Macleod

Busy at routine. Col. Irvine caused an information to be laid against one Creighton(?) for offering an I. to sell of horses(?) unlawfully. I sent warrant out tonight with orders to have him here tomorrow

Spring drill going on.

Friday 11 Macleod

Fined Dan Creighton(?) 50.00 and costs of court or (*xed out* three) two months for contravention of Indian Act re obtaining property from Indians without any authority whatever. He \_\_\_\_\_ one Harry Hawes(?) in his defence and he was the strongest one against him

Saturday 12 Macleod

Weather fine. 40° deg. at 9.30 drill (Spring) going on. Did lots of work and had a great deal of bother(?).

Ordered \_\_\_\_\_ and team for Campbell & prisoners J.W. Murray and Welch.

Told Baker to get the oats as soon as possible to make up S.S. Fanes(?) bad work. He says he can get them for seventy(?) cents a hundred perhaps less.

Sunday 13 Macleod

Church parade as usual. Raw day.

Inspected the Barracks, \_\_\_\_ Kitchen etc and the Dr absent must give an order re the Inspections and attendance

Monday 14 Macleod

Busy all day weather cold and cloudy

Tuesday 15 Macleod

Weather fine. Busy in the office all day. Macdonell preparing to go to Mosquito Creek to inspect.

Wednesday 16 (*xed out* Weather) Macleod

Nothing of importance

Busy in the office all day

Macdonell went to Mosquito Creek to inspect the post and that at the Leavings also. J(?) Cowdry accompanied him.

Thursday 17 Macleod

Weather fine. Drill as usual. Attended to a good deal of work

Wroughton sent out to inspect the (*xed out* Division) horses. Pincher Creek Kootenai and Big Bend. Drayner went with him

Friday 18 Macleod

Weather raw. no drill to(sic) cold for it as it is done standing in squads with intervals

Busy at routine and office work all forenoon

Inspected the guard, guard room, cells, Stables of D. Division. Saddle room ordered \_\_\_\_ routine boards and prisoners ditto to be made out at once.

The guard did not turn out properly. One Constable mixed up and Corporal too hurried in his words of command. Care must be taken to teach them the way to give words of command

Saturday 19 Macleod

Weather very fine. Recd telegram today from A Ross Cuthbert Insp Calgary asking for team to meet the Indian Comr (Reid) at Mosquito Creek Sunday night. Sent them at once. Another telegram at 1.00 which \_\_\_\_\_ to send 30 men to Lethbridge to replace same number of Deanes sent to "The Hat" CPRy strike. \_\_\_\_\_ with teams \_\_\_\_\_ i \_\_\_\_\_ and had horses shod Put 10 in wagons and 20 mounted they left at 7 P.M. under Sgt \_\_\_\_\_ one of them.

Busy at routine signed all monthly QM Store returns

Sunday 20 Macleod

Weather fine. No church parade, so many men away. Busy in orderly room nearly all day

Sent for "Lone Man" Cree Indian and asked him all about Mr Johnson the Coroners \_\_\_\_\_ investigation on Mrs McGillis child found that Johnsons report was false and that Lone Man in every respect corroborates the report made by White Fraser. Gave the Indian a half sack of flour some tea sugar and tobacco as a present. Told him that no matter what he said I would have done so. Wrote report, Confidential to the Comptroller re the Johnson case.

Deane writes \_\_\_\_\_ that [top of following page] he has not sent men to Hat yet

Monday 21 Macleod

Weather fine. 55° in shade

Lawn tennis played by townspeople. Matthews(?) to Med Hat with Deanes men. Tol him to take luggage in case of transfer. Foolish man. crazy about his boy and will be no use for duty while the boy is around.

Post in fine \_\_\_ orders \_\_\_\_\_ their hats, and on visiting stables found them not swept out clean. Gave orders to have officers inspect them. Wrote a number of letters to parties on duty.

Visited Hopl. stables etc. at 3.45 looked at awkward squad.

Played whist in the mess until 11.00 won 20 points lost none.

Tuesday 22 Macleod

Weather fine. Nothing of importance going on 60° in the shade at noon. 55 before noon

Tried several minor charges against men. Inspected the men in drill. Sent Const Quinn to the awkward squad under Mahoney. Did lots of routine work.

Informed the \_\_\_ behaved like a fool at Mosquito Creek on the way down

Wednesday 23

Weather fine. Drayner to Lethbridge to relieve Matthews who is to Moose Jaw. Drill as usual

Thursday 24 Macleod

Weather fine. Johnson & Johnson up before Insp Davidson for obtaining money under false pretences. Court sat until 10.30 at night. I gave evidence at 6.00. Bray and a great many witnesses called. Mail in. C.P.R. strike over so it is said. Some letters indicating that the usual low black guard system of spying on the Force is to be continued

Friday 25 Macleod

Weather fine. A little snow last night but all gone by 10.00

Johnson & Johnson committed for trial and admitted to bail by Insp Davidson \_\_\_

Young \_\_\_\_ Mrs \_\_\_\_'s son laid charges against George Robinson for attempt to commit buggery upon him. Admitted Robinson to bail self in \$500.00 and two in \$250 each. Sandy Macdonell and D. \_\_\_\_\_

Saturday 26 Ft Macleod

Weather fine 50° Fined two men Kirkman(?) and Devill(?) for breaking barracks, added 28 days C.B. Potter charged before Sanders and chgs dismissed but told that he could not be tolerated any longer if he did not behave himself.

Sunday 27 Macleod

No Church parade

Weather fine. Wrote many letters and signed one for Hd Quarters Mays went to church.

Monday 28 Macleod

Weather fine Drill as usual. Men getting on well. Did lots of routine work in orderly room. \_\_\_\_\_ in this afternoon.

Tuesday 29 Macleod

Saturday 9 Ft Macleod

Weather raw and windy. Awkward squad at drill in the forenoon. Laura Clifton up on a charge of not clearing away the rubbish around her dwelling under the ordinance for the unincorporated towns.

Busy at routine all morning. Const Quinn(?) up for overstaying pass and being brought back by escort, fined five and 28 days C.B. Arranged for a great deal of work for tomorrow morning while I am at church. Witnesses in Regina vs Johnson came with Bremmer and I gave them tents and rations

Sunday 10 Ft Macleod

Weather fine. Southeast wind. 50° in shade. Church as usual, crowded in ours. I inspected the barracks etc thoroughly at \_\_\_\_ and found all correct to a great extent. Corporal Ballards(?) room the best in the barracks. Saddles & harness in good order horses looking well

Mailed many letters re Recreation Room and other things as well

Monday 11 Ft Macleod

Galliher here. Reg. vs Johnson \_\_\_\_ going on. Busy all morning arranged as much work as possible.

Snow soft and north wind blowing

Tuesday 12 Macleod

Weather fine busy all day.

N.C.O. squad examined by me for drill at 2 P.M. they did not pass Mahoney having failed to put them at work at some of the movements in \_\_\_\_ and \_\_\_\_ front etc. Ordered that they practice them tomorrow as well as any other things required.

Wednesday 13 Macleod

Weather fine, very busy at office etc etc

Wednesday 27 Ft. Macleod

Sunday 22 Ft. Macleod

Weather fine. Wind north. Cancelled the parade in the morning on account of it. Sorry afterwards it having calmed down and it could have gone. Worked in the orderly room all forenoon.

Magistrates who entrusted it to his care during the time he was in the orderly room.  
He was brought in yesterday from Lethbridge \_\_\_\_\_ absent for five days, to the barracks  
in Lethbridge while he was under arrest, and has a charged against him to that effect.

### Tuesday 31 Macleod

Weather fine. Nothing of importance. Sgt Wright arranging to fix up the books  
papers etc ready for Sergt Morrison to take over the duties of orderly room clerk  
Telegram from the Com at 1.20 saying that 100 Sarkees are on the way here from thei  
Reserve without passes and directing me to have them escorted back to High River  
(xed out which I did)

A party was warned at once Inspr Drayner in charge with Potts they left in good time inside of an hour, delay caused because Potts could not be found at the time. Wrote to Mr Pocklington informing of the fact of the Indians (top of following page) movement.

## June

Wednesday 1

Weather cold, windy and dark. Very poor day racing of the S.A. \_\_\_. Assn I was Judge with Judge Macleod and Captain Macpherson of High River.

Sgt Turnbull drunk and got a bad fall from his horse. What a pity they cannot

Thursday 2 Macleod

Cold windy day, heavy wind last night. No racing or other games today. Ball at the Town Hall very early.

Friday 3 Macleod

Weather fine. Polo and La Crosse in the forenoon of the day Macleod badly beaten a polo.

Races a great success this P.M. fastest time yet made on this track. Macleod people lost a great deal of money by their horse Captain Samson(?)

I acted as one of the judges. Col Macleod and Macpherson one of the others.

Saturday 4 Ft Macleod

Two games of polo on the flat and Macleod won one of the cups High River the other Some pony races on the course of the S.A.T.A. I was judge with Pocklington in the afternoon.

Sunday 5 Ft Macleod

Weather fine. Nothing of importance. A parade for church as usual. Inspection of Barracks at dinner time, saddle room stables etc. No complaints. All correct

Monday 6 Ft Macleod

Tuesday 7 Ft Macleod

McIlree arrived this evening.

Wednesday 8 Ft Macleod

McIlree inspected the Bks and selected site for Canteen the same as I had selected for it before(?) He inspected canteen a/c. Did not think I should \_\_\_\_ upon the stock(?) not yet realized upon. I told him we could realize upon all of it in a few months. Shewed him plans of \_\_\_\_ and said \_\_\_\_ send \_\_\_\_ to him.

Thursday 9 Ft. Macleod

Weather fine. McIlree Macdonald and Mrs Macdonell left for Lethbridge at 10.30 I arranged all matters reported glanders(?) to McIlree gave notes of our wants here. etc

Friday 10 Macleod

Weather fine. Nothing of importance. Drill by squad both mounted and unmounted

Saturday 11 Macleod

Usual routine. Busy at Correspondence etc.

Sunday 12 Ft Macleod

Arranged to start for Boundary Creek tomorrow  
Busy at my returns etc.

Monday 13 Lees Creek

Left Macleod at 11.30 and reached Stand Off in two hours and fifteen minutes. Inspected the stables \_\_\_\_ etc and ordered necessary things Everything in good order and very clean. Left at four o'clock and reached here at seven 7.00 A good place plenty of pasture (160) and corrals stables etc. five rooms in the house. Sgt Wright in charge. Place rented from Bright at \$8.00 per mensum(?) \_\_\_\_ etc in good order. Dr. Allen and the Evans stayed at Cards \_\_\_\_ and I here for the night

#### Tuesday 14 Lees Creek

Left here in the morning and taking new trail went to Boundary Creek post. Found all the reports quite exaggerated re the wet, gave orders to Const Percival to do all he could to drain a spring on each side by making a \_\_\_\_ circular drain around the house, and to put some \_\_\_\_ sods on the roof. Everything kept in good order and very nice. Dined and went to St Marys Inspected but things were not so clean, Cotton(?) having been away in the past three or four days and only one man at home Reached Lees Creek after some trouble at the St Marys R which we had to cross with (top of following page) a boat very swift and high

#### Wednesday 15 Ft Macleod

Left Lees Creek at 8.30 arrived at Stand Off at 11.35 Belly river very high but not so bad as when we went up Sent Indian with note to Nelson(?) re Kjosterud got favorable reply \_\_\_\_ our horses, but was told Kjosterud was drowned at Kipp on Tuesday at noon. He had gone in bathing and must have taken cramp, the river cold and rapid He was a good swimmer Started at 2.00 and crossed the river which is very high. The little \_\_\_\_ is pretty bad right now.

Arrd here at 4.15 Saw drunken Indian but could not catch him. Stand Off clean

#### Thursday 16 Ft Macleod

Weather fine. Nothing of importance \_\_\_\_ \_\_\_\_ done except try drunks \_\_\_\_ men up for being drunk. Corporal Cudlip named for it. Corpl Browne \_\_\_\_ reduced to the bottom of the list of Corporals for neglect of duty four men two mos impt with H.L. for being drunk and generally useless through drunkenness.

Busy at routine. Weather fine. Drill both morning and evening mounted and dismounted.

#### Friday 17 Ft Macleod

Johnston Q.C. of Regina arrived to defend Old Johnson for defrauding the Minister of Justice. Also to defend Mr Cecil Denny from the charge of assault etc which was made against him

Drill twice a day on foot and Mtd and sword drill as well in the evening. busy all day went around the barracks and attended to routine duty. Retired late.

#### Saturday 18 Ft Macleod

Mess meeting at 7.00 P.M. Everything straight a few private a/c to pay up. Weather very hot pass(?) being burnt up all day I fear crops will be very poor. Johnston reports lots of rain in Regina district and Manitoba.

#### Sunday 19 Ft. Macleod

Weather hot, and very strong wind (Chinook), grass here browned up. No church parade on account of it. V.S. Wroughton visited from the Lethbridge District. Wrote several letters re Kjosteruds death by drowning.

#### Monday 20 Ft. Macleod

Weather changeable. Shower at 10.30 did not last long enough Crops suffering fror want of rain. Sent Const Macdonald to meet the Commissioner and take Mrs Bradley widow of Inspr Bradley to Lethbridge. Comr met the team at the bridges but did not turn them back as it was to much of a drive for them. He sent Mrs \_\_\_\_\_. Called on Comr at once after his arrival and then went to \_\_\_\_ correspondence in the orderly room.

Tuesday 21 Ft. Macleod

The Comr trying horses all day, only 13 selected but not all purebreds.

Busy myself at routine etc all day.

Officer of the day and a \_\_\_ of men were at the corral during the purchase of the horses. Burnett and \_\_\_ \_\_\_ that the (*xed out* staff) horses \_\_\_ \_\_\_ than usual.

Wednesday 22 Macleod

Comr purchased horses part of the morning. Rained hard last night . Arranged some matters in orderly room with Comr. Some trouble about the hay but a/c \_\_\_ straight. He inspected the stores of D and H to be condemned, and expressed himself as much pleased with H but thought too much taken by D for condemnation. Went to the herd camp inspected all the horses the house etc A \_\_\_ outside I found fault with Elliott for not having it sent in. Got approval for many things. Rained part of the day.

Thursday 23 Ft Macleod

Weather fine. Comr inspected the barrack rooms and hospital H rooms remarked upon as more \_\_\_ satisfactory Got authority to line the walls with boards instead of painting them, to be stained a pink(?) color.

Several Non Com officers and Constables up for a transfer \_\_\_ other matters. Ten(?) \_\_\_ to the Comr privately \_\_\_ nothing of importance

Friday 24 Macleod

Weather fine. Nothing of importance. I fined and imprisoned an Indian and squaw for being drunk. Sanders and I heard case of giving liquor to said Indians by Mrs La Chappelle a squaw Sentence deferred as she may clear herself on the evid.

Busy all day as usual. Drove out and dismissed a squad that had been riding under Sgt Wilde. Drove out to the grade of the C & E Ry

Saturday 25 Macleod

Very hot, busy as usual. A case of small pox in town gave orders to \_\_\_\_ to see that the patient was isolated

Sunday 26 Macleod

Weather hot Church parade. I attended no inspections as I was delayed in town by Judge Macleod re small pox case. Insp'r Davidson inspected the barracks instead I had done so during the week.

Monday 27                    Blank

Tuesday 28                    Blank

Wednesday 29

Insp'r Drayner to Mosquito Creek and end of track & \_\_\_\_ to inspect and warn the people of the small pox. I also wish to keep him at work as he is always trying to get some form of leave. Now it is the races at Pincher Creek on Friday next D. started yesterday morning for the outposts north I have asked for a written report

Thursday 30

Kennedy reported \_\_\_\_ to Comr for not doing as he ordered viz to put the guard \_\_\_\_ the small pox. I consider the guard is all right and I wrote to that effect. Drayner started for Pincher Creek. I gave him leave but kept him as long as I could without being too hard. Holiday on orders for tomorrow morning.

## July

Friday 1

To Lethbridge with Mays and youngster Mr Hogg C.E. We got very wet and very uncomfortable indeed Rained all afternoon at this place None at Macleod All got off nicely at 10.30.

Saturday 2 Macleod

All day at Lethbridge too hot to travel in the middle of the day. I left at 7.30 P.M. wit  
\_\_\_\_ for a companion and got here at 11.30 splendid night and easy on the horses.

### Sunday 3 Macleod

Up early. Fire broke out in the Stedmans(?) Livery Stable four horses burned to death  
The stable went up like a torch All hands in Bks were turned out with the Engine and  
worked with a will, preventing the flames from spreading any more. Building partly  
insured.

Kept men on all day until no further danger Morris O.O. in chg

### Monday 4 Macleod

Drayner (*xed out* was) down at scene of yesterdays fire, \_\_\_\_ all out and brought  
home the Engine. Gigot up about the gd on small pox camp I put on another man but  
would not \_\_\_\_ without Aylens advice. Gave orders to guard to keep constantly on  
the alert.

### Tuesday 5 Macleod

Sent more orders to the small pox guard. (*xed out* Provost) N.C.O. of gd to visit at  
night, the Sgt Provost by day.

The men \_\_\_\_ the above in chg

Wrote Gigot to inform him of it

### Wednesday 6 Leavings

Left here at 8.00 Met Const \_\_\_\_ on his way back to Macleod having left the two men  
for duty at End of track, reached Pine Coulee in an hour, and Mosquito Creek in 2½  
do. Stayed until 1.00 Examined arms, pasture field, rooms, etc Corpl Bullock(?) on  
duty in Macleod. Const Hoskins says he has been in detachment for five weeks and in  
all that time Ins Drayner has not once inspected it.

Went to end of track and saw Const \_\_\_\_ in charge. No complaints \_\_\_\_ 14 miles  
from here. Got here in an hour and

(top of following page) fifteen hard driving from track 2 horses \_\_\_\_\_

Thursday 7

Left "The Leavings" at 6.40 and reached here at 9.00 A.M. Went to work at once. Wrote Inspr Drayner re his not having obeyed orders to inspect the detachments on the 27 & 28 \_\_\_\_ go to the end of track he obeyed and replied to the accusation he admitted almost all and put his resignation in my hands. I took no notice of it. I wrote the Commissioner reporting Drayner and all connected with his falsehood and disobedience of orders. What a foolish fellow! and all to enable him to get to Pincher Creek for the 1<sup>st</sup> July inst

Friday 8 Ft Macleod

Weather fine, very hot Monthly report late through Const Denny and the Sergt O.R. not understanding how I wished it written. I was most annoyed and gave them to understand I was. The mail orderly was late on account of it and for the first time I was unable to send my mail off.

Drayner implored me to withdraw the report of his conduct re the inspection of Leavings and Mosquito Creek etc etc I gave him no satisfaction, but told him what I thought of his conduct

Busy all day Tried and dismissed some charges.

Saturday 9 Ft. Macleod

Weather fine and cooler than yesterday 80° in the shade. No \_\_\_\_ today. Busy at all sorts of work had to order my report to be rewritten. Denny astray in the knowledge of what was required.

Telegram from Mr Harwood stating that \_\_\_\_ died at 1.00 A.M. this day in Montreal

Teams started last night with \_\_\_\_ the Coroner to view the remains of Kjosterud Arranged for the funeral wrote Hilton about it. Cast horses to Calgary

Sunday 10 Ft Macleod

Weather very hot. No church parade on account of Hans Kjosteruds funeral which was with full military honors at 1.30 The casket was placed inside a zinc lined box Firing party 13 rank and file with 3 rds of small arms a photo taken at the grave while the volleys were being fired off. Sent Hilton with train to service for the Railway men at Brownings \_\_\_, as he had lost time by the funeral. All officers \_\_\_ (sick and \_\_\_) attended funeral Men looked well.

#### Monday 11 Ft Macleod

Weather fine but cool, no rain. Busy getting off all the correspondence and accounts of last month. Wrote Mays and Mr Harwood re poor \_\_\_ death Wrote Mr Kjosterud re his sons death burial etc Wrote for accounts of the funeral expenses to to T Bright and Company. Wrote Supt Jarvis re Drayners letter. Advised to \_\_\_ drop it or push it as he (D) was evading the question. Dr A\_\_\_ who left for Lees Creek \_\_\_ got back this A.M. Sgt Wright has broken rib.

#### Tuesday 12 Ft Macleod

Weather fine. Nothing of importance going on in the barracks.

Inspected the gd room, cells etc All correct. Busy in the office most of the day.

#### Wednesday 13 Ft Macleod

Dry weather. Crops suffering from want of rain. Busy at writing work.

#### Thursday 14 Ft Macleod

Usual Routine etc

Busy as usual.

#### Friday 15 Ft. Macleod

Sent a man to Blood agency to prevent whites from passing on to the Reserve without the Agents permission. Gave him written orders. Agent to instruct him if necessary

Sent \_\_\_\_ some men to Stand Off to \_\_\_\_ to Davidson to patrol more and keep whites off the Reserve particularly during Sun Dances  
Sent written orders very detailed as to the \_\_\_\_

Saturday 16 Ft Macleod

Weather fine but dry and a great drought prevailing for several weeks past  
Crops suffering The garden is not good

Sent men to increase the strength of the Kootenai and Big Bend detachments and gave stringent orders re patrolling and cattle killing by Indians. White Fraser and Davidson to report slightest infringement of the law in that respect.

Sent man to \_\_\_\_ on Reserve to have the whites off Reserve \_\_\_\_

Sunday 17 Ft. Macleod

Weather very windy. Had to cancel church parade on account of it. dined at Macdonells.

Monday 18 Ft. Macleod

Inspected Gd room, cells, pump house, pump, \_\_\_\_ all correct, except handles of pump which require repair at once. Gd room and cells very clean indeed.

Sent out \_\_\_\_ of \_\_\_\_  
\_\_\_\_ a rancher called to see me about something he states Corporal Stewart of H. Division said to him.

Tuesday 19 Ft. Macleod

Weather fine. Nothing of importance going on today, except the usual routine. Busy all forenoon at the usual returns for the post. Fined Const \_\_\_\_\_ for being drunk on duty. Going out to "End of Track"

Wednesday 20 Ft. Macleod

Weather fine Nothing of importance. The Lethbridge people up to play cricket.

Thursday 21 Macleod

Weather fine. Cricket match Lethbridge vs. Macleod. The Macleod team al police they had a good game. The Macleod people winning the game by 57 fifty seven runs. 36 the top score for an innings

Friday 22 Ft. Macleod

Weather fine but very windy. Sport commenced but given up on account of the storm of wind and dust. The Lethbridge people disappointed.

Saturday 23 Ft Macleod

Too windy to continue the sports. Busy at routine. Wrote lots of letters. Sent Denny(?) to Lethbridge to get an \_\_\_\_\_ to \_\_\_\_ the Walrond \_\_\_\_ in dispute.

Hilton went down so did \_\_\_\_\_ Sanders return to Regina.

Sunday 24 Ft. Macleod

The weather windy. No Church for C of E. The incumbent at Lethbridge preaching Col. Macleod read the service but did not do as well as usual.

Monday 25 Ft. Macleod

Weather cool, windy and cloudy. Sports going on (Annual) A good many people on the ground \_\_\_\_ not much to speak of. Not so good as last year.

Tuesday 26 Ft. Macleod

Weather cold and wet in the forenoon, cold in afternoon. Fires necessary. Busy at work all day. Mail small, very small indeed. Fined two men for drunkenness, and heard some other cases as well.

Wednesday 27 Ft. Macleod

Fine. Inspected the guard room, cells all correct. Hospital stables saddle room \_\_\_\_ for having dust on the saddles etc.

Inspected waggons and the barrack rooms and \_\_\_\_ \_\_\_\_.

Thursday 28 Ft Macleod

Weather fine. One man, Const Rogers up chgd with drunk and absent from evening stables, former chg not proved. Fined for the absence and C.B. Visited stables saddle rooms etc and looked around generally.

Very busy at routine. First hay of the season came in.

Friday 29 Ft. Macleod

Cool and pleasant. A few drops of rain. It comes now when not wanted, to spoil the hay.

Saturday 30 Ft Macleod

Weather warm. Usual routine.

Sunday 31 Ft. Macleod

Weather fine weather fine. Usual routine Very hot. Dined at Macdonells  
Wrote letters official and otherwise. Church parade as usual.

## August

Monday 1 Ft. Macleod

Weather fine but hot. Sent Potts and Jarvis to hunt up the Indians who broke  
into \_\_\_\_\_ house yesterday. They started for the Peigan Reserve. Sent  
word to Pocklington that the Engineers had commenced revising the line.  
Sent \_\_\_\_\_ to all the outposts re the robbery also sent a man to look for the  
horses of a half breed. \_\_\_\_\_ had five stolen \_\_\_\_\_ Assiniboine.

Tuesday 2 Macleod

Weather fine and hot, sultry. Fire in Crows Nest the cause. Tried Const \_\_\_\_\_  
for having left his post on the night of the 31<sup>st</sup> he being on Quarantine guard  
at the time. Very mixed up case.

Arranged to start tomorrow for the Dt and to halt at Cochrane for the  
night.

Wednesday 3 Cochrane Ranche

Weather very hot, 96° in the shade at 10 AM. Busy with cases in the orderly  
Room all morning. A lot of correspondence to go off \_\_\_\_\_ Macdonell  
instructed as to what to do about certain matters, Drayner case etc Left at 2.0  
picked up Hilton, drove to Stand Off, all correct

Davidson comfortable. Told him he need not \_\_\_\_ any \_\_\_\_\_ on patro yet as I am satisfied that the \_\_\_\_ of cattle killing is much exaggerated. Drov on after supper to here, kindly received as usual. One hour and three quarters from Stand Off. Distance 15 miles. Stand Off in good order.

Thursday 4 (*xed out* Ft Ma)

Left the Cochranes at 9.15 and reached Big Bend at 11.00 Weather fine but cool breeze blowing all day. Corporal Brown(?) at home. Looked around, inspected papers diaries stables and books. Ordered Brown to send in for a wheelbarrow which is wanted and to send \_\_\_\_\_ to Insp Davidson at Stand Off. Left at 3.40 P.M. and reached Kootenai at 5.40 Inspected and \_\_\_\_\_ books \_\_\_\_\_ etc. Const \_\_\_\_\_ ill, if worse Dr to be sent for. Horses to be fed more and worked less, for a time. Reached here at 644 - \_\_\_\_\_ 12.15

Friday 5 Ft Macleod

Usual routine.

Saturday 6 Ft Macleod

Weather cool. Usual routine.

Sunday 7 Ft Macleod

Weather fine. Usual routine. Church parade for all. Inspected the barracks and other institutions very thoroughly. Everything in good order the harness saddlery, arms and guard room & cells in particularly good order.

Monday 8 Ft. Macleod

Sent off a large mail as soon as possible and attended to many routine \_\_\_\_.

Tuesday 9 Pincher Creek (*xed out* Ft Macleod)

Weather fine. Left \_\_\_\_ after the arrival of the mail with four horse team. \_\_\_\_ reached Pincher Creek at 4.45 dined and stopped at \_\_\_\_ White Fraser called when he heard of my arrival. Mr Smith called. I arranged for a trip through the \_\_\_\_ country to the Falls of the Middle Fork

Wednesday 10 Pincher Creek

Up early. Went to HB Co Store the clerk told me that the caddy(?) of tea had been robbed from the store and that the Police did not follow the suspected men. Started at 10.00 AM and at "The Falls" at 12.00 the two \_\_\_\_ Returned at 6 PM Saw a great deal of haying going on A great deal of old grass among it.

Saw R. Morris(?) at night got him at 8.00. Dined and retired at 10.15.

Thursday 11 Ft Macleod

Up early. Went to the detachment post and thoroughly inspected stables, barracks, hay, garden, harness, saddlery etc the stables want \_\_\_\_ and the barracks white washing and \_\_\_\_ for the Church(?) Found that Indians come to the Creek(?) without passes and with them ordered that they be kept away as much as possible even if with passes.

Left Mr Hilton, who went to South Fork to a wedding and to fish with M<sup>l</sup> Smith (the Revd) I got here at 3.30 P.M. dined at 5.00 very dusty drive in good time Looked  
(continued next page) over my mail and attended to all of it at once.

Friday 12 Ft Macleod

A lawn tennis party in barracks. Busy all morning. Fined Crafter(?) for drunk. I am sorry as he is a good man. Gave Const Clarke of D. 14 days CB and an extra \_\_\_\_.

Visited Hospital saddle rooms and stables. Sick in the afternoon. But recovered in the evening.

### Saturday 13 Ft Macleod

Visited Hospital. Weather fine, busy in office and at other routine matters the men played cricket in the P.M.

### Sunday 14 Ft Macleod

Weather fine. Nothing of importance going on. Church parade except for C of E. The Revd. Mr Hilton not back from the Creek. Very windy in the morning. Pleasant in the evening.

### Monday 15 Ft. Macleod

Weather windy and hot. Sanders and I tried and fined one Whitford for being drunk and creating a disturbance on the Queens highway.

Randall up for being drunk last night.

Monthly returns for the Q.M. Store went off this A.M. Wrote a great many letters \_\_\_\_.

### Tuesday 16 Ft. Macleod

Entered up the receipt of Two hundred and thirty two dollars and ninety seven cents (\$232.97)

Wednesday 17 Ft. Macleod

Weather fine. Usual routine. Constable Colebrook arrested for drunk and disorderly and trying to use firearms in barracks

Thursday 18 Ft Macleod

Weather damp. Very heavy rain last night. Usual routine work going on. Feel very unwell, had to take medicine and abstain from work in the afternoon.

Ordered in the last of the men who have not done their foot drill.

Friday 19 Ft. Macleod

Busy all day, wrote a great many letters. Still quite unwell. Inspected stables saddle rooms, Gd room and cells, all correct.

The small pox camp being vacated by the patients and nurses the staff all \_\_\_\_\_ by the Health officer. The Guard to be taken off tomorrow. Will not relax any rules re Indians as yet.

Mail which \_\_\_\_\_ large.

Saturday 20 Ft. Macleod

Usual routine.

Sunday 21 Ft. Macleod

No Church of E \_\_\_\_\_ parsons arrival unknown, other denominations paraded.

Sent SSgt Evans to enquire re the rape or attempt to commit rape by Const Mc \_\_\_\_\_ and had the latter confined in the guard room

## Monday 22 Ft Macleod

Weather fine but very hot indeed. I sat on the rape case It is strong against the prisoner McD.

Sanders and I fined two \_\_\_\_ \$5.00 and costs or ten days for drunk and creating a disturbance.

## Tuesday 23 Ft Macleod

I committed Const Macdonell for trial for attempt to rape Susan(?) Kennedy a half breed woman. Strong case made out. Fined Const Daly ten dollars and two months impt with H.L. for \_\_\_\_ and obscene language to Sgt Marshall on duty in Canteen

## Wednesday 24 Ft. Macleod

Weather fine. \_\_\_\_ several cases in O.R. One drunk (\_\_\_\_) dismissed for want of evidence. Very large mail went out this A.M.

## Thursday 25 Lees Creek Det

Weather fine. Rain last night. Lieut Governor Shultz of Man. at hotel, the Macleod house. I called and upon his request drove him up to the barracks at 11.15 \_\_\_\_\_. He went to the mess. Presented the officers to him, and with them accompanied him around the Bks. He expressed himself as much pleased with everything he saw. I accompanied him to the hotel and provided him with a team to take him to Pincher Creek as per orders from Hd Qrs. Left for here at 3.00 and arrd at 9.00 Trail very heavy.

## Friday 26 Lees Creek

Weather cloudy in the forenoon. Bright C.E. to the St Marys 'R' to find paint for the bridge. Let Sgt Wright assist him. Went to Shaws to have \_\_\_\_ fixed. Not successful waited then until J.B. Bright came \_\_\_\_ up He found a place, but below Lees Creek. He left for home. Slept late. Caught in terrific hail and thunder storm Close call from Lightning Got wet. Horses very frightened

### Saturday 27 Lees Creek
